**APRIL 18, 2016**

**HELD AT THE ANGELICA GRANGE**

Mayor Trivisonoli called the Organizational meeting to order at 7:51pm.

Mayor Trivisonoli thanked past board member Dana Claypool.

Mayor Trivisonoli appointed Trustee Linda Warner as Deputy Mayor.

**2016 APPOINTMENTS** – Trustee Perry motioned to approve the Mayor’s appointments for 2016-2017 – second Trustee Grusendorf – Warner-Aye, Perry-Aye, Grusendorf-Aye, Claypool-Aye, Trivisonoli-Aye – carried.

**RESOLUTION (#12-0416) – ADVANCE OF AUDIT CLAIMS** – Offered by Trustee Warner and seconded by Trustee Perry – the Board of Trustees has determined to authorize payment in advance of audit claims for public utility services, postage, freight and express charges – all such claims must be presented at the next regular meeting for audit and the claimant and the officer incurring or approving the claim are jointly and severally liable for any amount the board of trustees disallows – (see attached)

**RESOLUTION (#13-0416) – MILEAGE REIMBURSEMENT** – Offered by Trustee Grusendorf and seconded by Trustee Warner – the Board of Trustees has determined to pay a fixed rate for mileage as reimbursement to village officers and employees who use their personal automobiles while performing their official village duties – the board of trustees will approve reimbursement to such officers and employees at the rate of 50 cents per mile – (see attached)

**RESOLUTION (#14-0416) – OFFICIAL DEPOSITORY** – Offered by Trustee Claypool and seconded by Mayor Trivisonoli – the Board of Trustees has determined that Village Law §4-412 (3) (2) requires the designation of banks or trust companies for the deposit of all village monies; the board of trustees designates the following institutions as depositories of all monies received by the village treasurer, clerk, and receiver of taxes. Names of institutions: Community Bank, N.A. (Angelica Branch) and New York CLASS and Fiver Star Bank (see attached)

**RESOLUTION (#18-0416) – MUTUAL AID AGREEMENT BETWEEN THE MUNICIPALITIES OF ALLEGANY COUNTY, NEW YORK** – Offered by Trustee Warner and seconded by Trustee Perry – Whereas, the Board of Trustees of the Village of Angelica hereby agrees to allow Kevin Demick, Streets Supervisor to extend Mutual Aid assistance to another participating municipality within the County of Allegany when requested to do so by such municipality in time of abnormal snow or work conditions.
