Archie McRae – Water Department

- Submitted monthly water report to county; met with NE Controls about SCADA system; sent letter to Senator Cathy Young for funding for SCADA System sent email and going to send packet about funding options; leak at Todd Haggstrom's on Peavy Rd and one at Sharron Miller's on Railroad Ave; installed a new line at 138 Center Street customer had no pressure; made connection on Joncy Bridge; top soiled/blacktopped and fixed ditch at Brooklyn St; mapped out more services; fixed CL2 Pump; normal monthly duties testing, meter reading shut offs, UFPO's etc.
