

ORGANIZATIONAL MEETING OF THE VILLAGE OF ANGELICA BOARD OF TRUSTEES

APRIL 21, 2014

HELD AT THE ANGELICA GRANGE

Mayor Robbins called the Organizational meeting to order at 7:00pm.

Newly Elected Trustees Michael Trivisondoli and Linda Warner were sworn in.

2014 APPOINTMENTS – Trustee Warner motioned to approve the Mayor’s appointments for 2014-2015 – second Trustee R. McKnight – R. McKnight-Aye, D. McKnight-Aye, Trivisondoli-Aye, Warner-Aye, Robbins-Aye – carried.

RESOLUTION – ADVANCE OF AUDIT CLAIMS – Offered by Trustee Trivisondoli and seconded by Trustee D. McKnight – the Board of Trustees has determined to authorize payment in advance of audit claims for public utility services, postage, freight and express charges – all such claims must be presented at the next regular meeting for audit and the claimant and the officer incurring or approving the claim are jointly and severally liable for any amount the board of trustees disallows – (see attached)

RESOLUTION – MILEAGE REIMBURSEMENT – Offered by Trustee Trivisondoli and seconded by Trustee D. McKnight – the Board of Trustees has determined to pay a fixed rate for mileage as reimbursement to village officers and employees who use their personal automobiles while performing their official village duties – the board of trustees will approve reimbursement to such officers and employees at the rate of 50 cents per mile – (see attached)

McKnight and seconded by Trustee Trivisondoli – the Board of Trustees has determined that Village Law §4-412 (3)(2) requires the designation of banks or trust companies for the deposit of all village monies; the board of trustees designates the following institutions as depositories of all monies received by the village treasurer, clerk, and receiver of taxes. Names of institutions: Community Bank, N.A. (Angelica Branch) and New York CLASS and JPMorgan Chase (see attached)
