

**ORGANIZATIONAL MEETING OF THE VILLAGE OF ANGELICA BOARD OF TRUSTEES**

**APRIL 15, 2013**

**HELD AT THE ANGELICA GRANGE**

Mayor Robbins called the Organizational meeting to order at 7:00pm.

Newly Elected Mayor Robin K. Robbins and Trustees Ryan McKnight and Dean McKnight were sworn in.

**2012 APPOINTMENTS** – Trustee R. McKnight motioned to approve the Mayor’s appointments for 2013-2014 – second Trustee D. McKnight – R. McKnight-Aye, D. McKnight-Aye, Robbins-Aye – carried.

**RESOLUTION – ADVANCE OF AUDIT CLAIMS** – Offered by Trustee D. McKnight and seconded by Trustee R. McKnight – the Board of Trustees has determined to authorize payment in advance of audit claims for public utility services, postage, freight and express charges – all such claims must be presented at the next regular meeting for audit and the claimant and the officer incurring or approving the claim are jointly and severally liable for any amount the board of trustees disallows – (see attached)

The Mayor therefore declared the resolution duly adopted.

**RESOLUTION – MILEAGE REIMBURSEMENT** – Offered by Trustee R. McKnight and seconded by Trustee D. McKnight – the Board of Trustees has determined to pay a fixed rate for mileage as reimbursement to village officers and employees who use their personal automobiles while performing their official village duties – the board of trustees will approve reimbursement to such officers and employees at the rate of 50 cents per mile – (see attached)

**RESOLUTION – OFFICIAL DEPOSITORY** – Offered by Trustee D. McKnight and seconded by Trustee R. McKnight – the Board of Trustees has determined that Village Law §4-412 (3)(2) requires the designation of banks or trust companies for the deposit of all village monies; - the board of trustees designates the following institutions as depositories of all monies received by the village treasurer, clerk, and receiver of taxes. Names of institutions: Community Bank, N.A. (Angelica Branch) and New York CLASS and JPMorgan Chase (see attached)

**RESOLUTION – SCHEDULE OF REGULAR BOARD MEETINGS** – Offered by Trustee D. McKnight and seconded by Trustee R. **RESOLUTION – ATTENDANCE AT SCHOOLS AND CONFERENCES** – Offered by Trustee R. McKnight and seconded by Trustee D. McKnight – Officers and employees are authorized to attend schools and or training upon board approval for the coming official year – (see attached)

**RESOLUTION – MUTUAL AID AGREEMENT BETWEEN THE MUNICIPALITIES OF ALLEGANY COUNTY, NEW YORK** – Offered by Trustee D. McKnight and seconded by Trustee R. McKnight – Whereas, the Board of Trustees of the Village of Angelica hereby agrees to allow Kevin Demick, Street Supervisor to extend Mutual Aid assistance to another participating municipality within the County of Allegany when requested to do so by such municipality in time of abnormal snow or work conditions. This agreement is subject to the conditions listed in the written agreement - (see attached)
