Heath Gordon – Electric Department

• No Hydro reduction for March 2014. Few outages due to RG&E – switched us over to National Grid which puts a stain on our system because of low voltage coming in; few customers had some burnt connectors; line patrolled and voltage reads in different locations throughout our system due to the cold weather; will get to street lights when cold weather breaks; attended the NYMPA meeting in Syracuse on February 6th – A resolution was passed to allow NYMPA to bill anywhere from 42 mill to 92 mill through April 30, 2014. Don't expect February bill to be as high as the January but still more then paid in prior years.

Kevin Demick – Streets Department

Routine winter snow removal; salt usage running slightly higher this year - have enough in budget to buy one more load – may need to purchase an additional load from our equipment repair fund; submitted for NYS CHIPs program - \$59,188.54; demolished house on West Main Street on today (2/18/14); working on grant funding for plow truck with Rural Development.

Police Department – January report submitted. Recommends the board interview Steven Hanrahan for PT Police Officer – in the academy and will graduate in May 2014. Would like the board to consider allowing patrols on I-86 – will submit a written policy for the board to review.

Fire Department – Dana Guinnip reported that Tanker #7 was sent to Buffalo for repairs for bad sending unit.

Justice – Burke (\$766) Acting Village Justice Michael Burke advised the board that they need to update the village laws pertaining to violation/fine – board advised him to get sample law and they will send to village attorney
